HANDICAPS/	<b>February 16th</b> handicap indexes will be used with a maximum Playing Handicap of 36.	
STROKES:	The player with the lower Course Handicap is allowed 60% of Course Handicap; the player	
	with the higher Course Handicap is allowed 40% of Course Handicap. The overall winner	
	and flight winners will be awarded on NET scores. Ties for both Overall and Flight	
	winners will be determined via scorecard playoff using the USGA recommended method	
	as defined in USGA Rules of Golf - Committee Procedures (Section 5A(6)).
