- WHERE:** **Omni Tucson National Golf Course**

- WHEN:** **May 12-13, 2025**
- FORMAT:** **Two (2) Women Teams -- Better Ball Both Days**
The Overall Champions will be the teams with the lowest gross and lowest net scores. The field will be divided into flights with Low Gross and Low Net winners in each flight. Ties will be determined via scorecard playoff using USGA recommended method as defined in USGA Rules of Golf - Committee Procedures (Section 5A(6)).
- TIME:** **8:00 AM Shotgun both days** - Registration: 6:30 AM to 7:20 AM on May 12th
Complimentary range balls available - range opens at 6:30 AM
- HANDICAPS/
STROKES:** **May 9th** handicap indexes will be used with a maximum Playing Handicap of 36.
Playing Handicap will be based on 85% of a player's course handicap.
- ELIGIBILITY:** A participant must be a paid-up member of AGA and SDWGA by the opening date of the tournament registration (March 31, 2025). Please register from your HOME club.
- ENTRY FEE:** **\$185.00 per player/\$370.00 per team. Checks payable to SDWGA. One (1) entry per envelope.**
- OPENING DATE:** **March 31, 2025 (POSTMARK DATE).** Early entries will be returned.
Partner Substitutions will be allowed; however, if there is a wait list, the remaining partner and her new partner will be placed at the bottom of the wait list.
- CLOSING DATE:** **May 5, 2025** - Refunds may/may not be given after May 5th.
- FIELD:** **Sixty (60) teams.** All entries received over the allotted number of teams will be placed on a wait list in order of postmark date. You are IN the tournament if you are NOT notified by April 14th. Wait list teams will be notified by email or phone. Participant and Wait Lists will be available on SDWGA website beginning April 14th.
- COURSE/TEES:** **Catalina course May 12th (day 1), Sonora course May 13th (day 2). Tees TBD**
- LUNCHEON:** **Immediately following golf on May 13th (day 2)**
- PRIZES:** Certificates from Omni Tucson National for merchandise at the pro shop
- DRESS CODE:** Appropriate golf attire. This is a soft spike facility.
- PRACTICE ROUND:** **\$70/person starting May 1.** Call the pro shop and mention Southern District WGA to reserve a tee time. Pro shop phone number is 520-297-2271.
